At the Elliott Federal Credit Union, we are required to follow federal examiner guidelines as with other financial institutions. We are required to inquire about the purpose or source of ALL cash transactions that are \$2000 and over.

CREDIT UNION POLICIES

- ALL CHECKS ARE SUBJECT TO VERFICATION BEFORE FUNDS CAN BE RELEASED.
- STANDARD HOLDS WILL APPLY FOR AMOUNTS OVER \$225 WITHOUT MATCHING FUNDS
- WE WILL MAKE EVERY EFFORT TO VERIFY FUNDS TO EXPIDITE THE PROCESS.
